Timeline of What Happens After Your Claim is Submitted

3 Bellwether Trials & Settlement Negotiations (2-4 Years)

- ✓ A few selected cases go to trial as test cases (bellwether trials).
- ✓ If plaintiffs win, the defendant may offer a settlement to avoid more trials.
- ✓ If settlement talks fail, additional trials may occur.

What to Expect: Bellwether trials help determine settlement values. If successful, settlements may move faster for other plaintiffs.

📌 Tip: Many cases settle at this stage, but if yours doesn't, you may need to wait for further legal decisions.

4 Settlement Distribution or Trial Verdict (3-5+ Years)

- ✓ If a settlement is reached, funds are distributed based on injury severity.
- ✓ If a **trial verdict** is in favor of the plaintiffs, compensation is determined by the court.
- ✓ If the defendant appeals, the case may take longer.

X What to Expect: If you accept a settlement, your compensation will be processed after legal fees and expenses are deducted.

- Refuse to Settle The case moves to trial for further litigation.

- ✓ Pain and suffering damages
- ✓ Severity of injuries
- ✓ The strength of evidence against the defendant
